

• ASEAN and Norway, through the Norwegian-ASEAN Regional Integration Programme (NARIP), launched the ASEAN-Norwegian Cooperation Project on Local Capacity Building for Reducing Plastic Pollution in the ASEAN Region (ASEANO).



- ASEANO is the ASEAN-Norwegian Cooperation Project under AWGCME.
- **ASEANO** runs from 2019 to 2022 and focuses on capacity building and knowledge development in tackling plastic pollution from the main sources in the ASEAN Region.
- **ASEANO** start activities in Cambodia through the National Stakeholders Workshop on Local Capacity Building for Reducing Plastic Pollution in Tonle Sap.
- The workshop aimed to identify past and ongoing initiatives related to plastic waste and to understand, explore and exchange ideas, solutions and the way forwards to tackle the plastic waste issues around Tonle Sap Lake

## ASEANO 2 (ASEAN-Norwegian Cooperation Project Phrase 2)

#### ASEANO 2

- Project duration: 4 years (2023-2026)
- Funding Source(s): Norwegian-ASEAN Regional Integration Programme (NARIP)
- Proposed Project Budget (total in USD): USD 3,678,500.00
- The project aims to improve the local and global environment through reducing the riverine discharge of plastic pollution to the sea, without adverse effects.
- Objectives of the ASEANO2 project includes illuminating driving forces behind plastic pollution and evaluate its implications for economy, development, environment, and human well-being, with focus on local municipality/city level sustainability.







## ASEANO 2 (ASEAN-Norwegian Cooperation Project Phrase 2)

- Main goals for the ASEANO2 project will be to provide science-based knowledge on sources, releases and riverine transport of plastic litter to the marine environment, targeting policy and decision makers within public and private sectors as well as knowledge providers and brokers within academia and NGOs.
- Main objective for the ASEANO2 project is to develop targeted and cost-efficient prevention and mitigation measures for plastic pollution in ASEAN through a multidisciplinary, cross-sectorial and holistic approach.
- Project outcome are
  - Outcome 1: Establish local river monitoring capacity
  - Outcome 2: Explore and assess effects of measures and mechanisms for the plastic value chain
  - Outcome 3: Investigation of public awareness of plastic pollution: from households to local community
  - Outcome 4: Improved policy implementation under different cultural and socio-economic settings
  - Outcome 5: Development of integrated knowledge-based mitigation planning







# ASEANO 2 (ASEAN-Norwegian Cooperation Project Phrase 2)

- ASEANO 2 is a next-phase project building upon previous project ASEANO
- From three sites in ASEANO (in Indonesia, Philippines and Vietnam), ASEANO2 will widen the number of study areas to include Thailand and **Cambodia**.
- Tonle Sap Multiple Use Area is proposed as the project site in Cambodia.
- ASEANO2 was endorsed by the ASEAN Working Group on Coastal and Marine Environment (AWGCME), ASEAN Senior Officials on Environment (ASOEN), and Committee of Permanent Representatives to ASEAN (CPR). The approved letter already sent to Norway Government.
- The project will work towards a more sustainable and effective resource utilization, with circularity of resources as means to protect both the environment and human wellbeing from plastic pollution.
