## Opening Remarks by H.E. Mr. Norio Mitsuya, Parliamentary Senior Vice-Minister for Foreign Affairs of Japan At the UNCRD/UNDESA Side Event "Promoting Resource Efficiency for Sustainable Urban Development"

Excellencies, Ladies and Gentlemen,

It is my great honor to make the opening remarks for this event today on behalf of the Ministry of Foreign Affairs of Japan. I would like to take this occasion to welcome the participants in this room to the Third World Conference on Disaster Risk Reduction to be held in Sendai, Japan in March next year.

I am very pleased that Mr. Toshihiko Ohta, Mayor of Toyota City and Mr. Hiroshi Imanaga, Deputy Mayor of Kitakyushu City are joining us today as panelists. I am fully convinced that these two cities are excellent role models for other city leaders in the world in identifying effective policies and tools for promoting sustainable urban development, bearing in mind the importance of resource efficiency. I equally look forward to the presentations from other panelists.

I hope this event will further contribute to raising visibility at the international level concerning the UNCRD's vital role and activities to assist developing countries in their transition to a more sustainable society. Let me conclude by wishing a great success of the event.
