

Integrated plan for waste-to-energy

- paradigm shift to energy recovery
- ECO STAR Project global new technology
- Expansion of WTE facilities

- 100% energy recovery of waste by 2020 : 3.8 mil ton('12) to 12.18 mil ton by 2020
- : 1.28mil Gcal/year exhausted heat recovery
- : 160 m³/day landfill gas energy recovery
- alternative source for fossil fuel energy
- carbon reduction and carbon trading
- reduction of waste management costs
- economic growth and climate change mitigation

Global Waste Management (Waste-to-Energy) Market


Large share of market in Europe and America








