The Seventh Special Thematic Session on Water and Disasters "Water and Disasters for Cooperation and Partnerships" United Nations Headquarters, New York

8 July 2025

1. Background and Objective

The UN Special Thematic Sessions on Water and Disasters (STSWD) have been held biennially since 2013. The Seventh Special Thematic Session on Water and Disasters (STSWD7) will take place on 8 July 2025 as part of the lead-up to the 2026 UN Water Conference. It will build on the discussions and outcomes of the 2023 UN Water Conference while continuing its mission to raise awareness, foster cooperation, and drive action on water and disaster-related issues within the broader development agenda.

Water is not a tool for conflict but a powerful catalyst for cooperation. Historically, water-related disasters have provided opportunities for neighboring countries to collaborate by sharing information and offering mutual support. Over the past fifty years, water has played a significant role in fostering peace, as evidenced by 1,200 diplomatic events—two-thirds of the 1,800 recorded water-related diplomatic engagements. Transboundary water cooperation remains a crucial pathway to peace and must be actively pursued. Protecting water resources is essential for the well-being of both people and the planet.

While water often unites, it can also be a source of tension. Floods, droughts, and pollution, especially when exacerbated by natural disasters, can lead to technological crises, waterborne disease outbreaks, and strained international relations. Inadequate disaster response can further destabilize affected regions. Poor water management and regional disputes may even result in transboundary disasters, such as dam failures, highlighting the critical need for joint basin management to prevent long-term conflicts.

However, as history has shown, water-related disasters also present unique opportunities for cooperation. By sharing critical information and providing mutual assistance in times of crisis, countries can strengthen trust and deepen partnerships. Turning these challenges into opportunities requires preparation, proactive measures, and sustained collaboration.

With this background, STSWD7 will build on previous sessions by maintaining high-level political engagement and advocating for concrete action to address the interlinked challenges of water and disaster risk reduction among UN member states. The outcomes of the session will feed into global dialogues such as the Dushanbe Process and the UN Water Conferences in 2026 and 2028. Together, these discussions will help forge stronger partnerships among water stakeholders, advancing the shared goal of peace and sustainable water management.
