<p><b>Q-3 Total annual government expenditure per capita (US\$ per capita) in municipal solid waste management in 2014-2015</b></p> <p>According to the 2014/15 Cook Islands Government Appropriation Bill, NZD\$550,000 was allocated to waste management, roughly equating to USD375,000. The 2016 Cook Islands census count was 17,434, of which 14,802 was resident population. Based on the latter figure, this provides a per capita figure of US\$25 per person.          This was complemented by NZD\$2,175,000 (approx. US\$1.5mil) of development funding also received that financial year (2014/2015) from New Zealand for further waste management and sanitation improvement programs.</p>
